Crime Statistics

The month of March 2025 indicated a 4% decrease in Group A offenses in comparison to March 2024. There was a 5% increase in Group A offenses year to date. This decrease can be attributed to less incidents of Fraud. There was a 50% increase in Group B offenses compared to March 2024. This increase is due to more Criminal Trespass arrests.

Town Center

The Police Department responded to sixty-four (64) calls for service at the Town Center properties in March 2025; of those calls there were forty-two (42) reported crimes, which included eighteen (18) Retail Thefts and eighteen (18) Panhandlers/Removals. There was a thirty-six percent (36%) increase in calls for service in comparison to March 2024 statistics. In addition, there was a fifty percent (50%) increase in Criminal Activity in comparison to March 2024 statistics. This increase can be attributed to an increase in Retail Theft and Panhandler/Removal Calls.

Community Policing/Crime Prevention Activities:

Directed Patrols/Traffic Enforcement

The Midnight Shift focused enforcement on Harlem Avenue. Dayshift was assigned to traffic enforcement missions on Augusta Street, North Avenue, Division Street and Madison Street. The Afternoon Shift conducted enforcement missions in the area of Chicago Avenue, Division Street, Harlem and Madison Street.

The Midnight Shift made twenty-three (23) stops, issued twenty-six (26) citations and ten (10) warnings were issued during their traffic missions. The shift made three (3) traffic arrests, and three (3) vehicles were administratively towed during the enforcement traffic mission this month.

The Dayshift made thirty-four (34) stops, forty-three (43) citations and eleven (11) warnings issued. The shift recorded six (6) traffic-related arrests during enforcement missions this month. Five (5) vehicles were administratively towed.

The Afternoon shift made sixty-four (64) stops with sixty (60) citations and twenty-one (21) warnings issued during traffic enforcement missions. The shift recorded eight (8) traffic-related arrests, and four (4) vehicles were administratively towed.

Notable Events and Arrests:

25-00248 Driving Under the Influence

On March 2, 2025, 5:49AM, River Forest officers were dispatched to the area of North Avenue and Park Avenue for a vehicle accident. Upon arrival, officers determined the at-fault driver, a 49 year old female from Chicago, exhibited signs of alcohol impairment, admitted to consuming alcohol, failed field sobriety tests, and was arrested for Driving Under the Influence of Alcohol. At the station, she provided a sample revealing a Blood Alcohol Content of 0.219. She was processed and later released on a Citation and Notice. The vehicle was towed with an administrative hold placed on the vehicle.

On March 3, 2025, 10:55AM, a River Forest unit stopped a motorist near the intersection of Augusta Street and Park Avenue for a traffic violation. 25-00254 Retail Theft/ Resisting / Criminal Trespass / Warrant X2

On March 4, 2025, 1:42PM, River Forest units responded to 7245 Lake Street (Whole Foods) for a retail theft and located the offender, a 52 year old female from Chicago, near the intersection of Harlem Avenue and Central Avenue. The offender resisted arrest but was taken into custody. The offender and proceeds were positively identified by the victim, and she was discovered to have two valid warrants out of DuPage County. The offender was transported to the station where she charged with retail theft, resisting, criminal trespass and the warrants. She was issued a Citation and Notice for local charges and later transported to Maybrook for the warrants.

The responding officers located a tow truck driver who advised that he towed a vehicle for improper parking in the private lot at 7200 Oak Avenue. The tow truck driver stated he drove to Lake Street and Clinton Place to secure the vehicle. The tow truck driver stated the offender ran down the street, entered the towed vehicle, and refused to exit the vehicle. Responding officers ordered the offender to exit the vehicle and the offender refused. The offender, a 49 year old male River Forest resident, obstructed and resisted arrested. The offender was transported to the station for processing and charged with disorderly conduct, obstructing a peace officer, and resisting a peace officer. The offender was given a misdemeanor court date and released on Citation and Notice.

25-00262 Warrant Arrest (x2)

On March 6, 2025, 4:33PM, River Forest Tactical Officers were patrolling in the area of the River Forest Town Center, 7200 Lake Street, when they observed a male subject who appeared to be nodding off in front of the Whole Foods. Officers then observed a female subject walk hastily out of the store with loose proceeds in her hand and left with the male subject. Believing that the female subject had committed a retail theft, the officers conducted an investigatory stop on the subjects and confirmed that a retail theft was committed. Officers also learned that both the female and female subjects had active arrest warrants for theft related offenses and domestic battery. The female, a 25-year-old Naperville resident, was arrested and charged with an active DuPage County warrant. The female was turned over to the DuPage County Jail. The male, a 27-year-old Elgin resident, was arrested and charged with two active warrants, one from DuPage, and one from the Bensenville Police Department. The male was turned over to the Bensenville Police Department.

The offender, a 37 year old male from Oak Park, was confirmed to have been banned from Walgreens in December of 2024. The offender was issued a local ordinance citation for petit larceny and given an administrative hearing date. The offender was released, and River Grove Police took custody of the wanted offender.

On March 23, 2025, 1:48PM, a River Forest patrol unit received a notification from the Osprey LPR database for suspended registration. The officer confirmed the hit and stopped the vehicle near the intersection of North Avenue and Jackson Avenue. The driver, a 36 year old male from Chicago, had a TVDL that was invalidated by the lack of insurance.
