 - I. 210 Gale Avenue Garage Streetscape Compatibility Award

II. 727 Keystone Avenue – Rear Addition – Renovation Award

Chairman Franek noted that the new addition blends seamlessly into the existing structure.

III. 823 Keystone Avenue – Siding, Roof, Front Porch, and Landscaping –Laurel McMahon Restoration Award

Chairmen Franek gave background information on the award and congratulated the applicants at the meeting for their hard work. He noted that improving an older home like 823 Keystone is not easy work.

The applicant, Keith Strom, suggested the Village announce these awards so as to help bring more attention to the work that the Commission does.

Mr. Strom suggested the local newspapers be informed as well.

Lisa Rodriguez gave additional background information on the application and the work done on the home.
