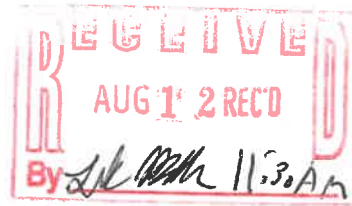

**OBJECTOR’S PETITION**

Objector, **Carolyn A. Kilbride**, states that Objector resides at 1335 Park Avenue, River Forest, Illinois 60305, respectively, that Objector is a duly qualified and registered legal voter of the Village of River Forest, Cook County, State of Illinois, the district in which the Petition for Referendum is to be voted upon, and that Objector’s interest in filing the following objections is that of a citizens desirous of seeing that the election laws and ordinances governing the filing of Petitions for Referendum by Deborah L. Borman, Principal Proponent, seeking placement of the question “Shall the terms of office of the Village President of the Village of River Forest, Cook County, Illinois be limited so that, effective upon the passage of this question as certified by the election authority no person may serve as Village President for more than a total of eight (8) years?” in the Village of River Forest, Cook County, Illinois, are properly complied with, that only public questions be presented to the voters of the Village of River Forest and election authorities which are clear and unambiguous, that elected officials, such as Catherine M. Adduci, who Objector and the voters of the Village of River Forest voted for and elected to the Office of Village President of the Village of River Forest at the April 6, 2021 Consolidated General Election do not have their terms of office cut short, and that only legal and proper public questions by referendum appear on the ballot for the November 5, 2024 Presidential General Election.

Therefore, Objector makes the following objections to the Petition for Referendum in the Village of River Forest to be voted upon at the the November 5, 2024 Presidential General Election:

### **PARTIES**

1. Objector, Carolyn A. Kilbride, (“Objector”) is a duly qualified, legal and registered voter in the Village of River Forrest at 1335 Park Avenue, River Forest, Illinois 60305. Objector’s interest in filing the following objections is that of a citizens desirous of seeing that the election laws and ordinances governing the filing of Petitions for Referendum by Deborah L. Borman, Principal Proponent, seeking placement of the question “Shall the terms of office of the Village President of the Village of River Forest, Cook County, Illinois be limited so that, effective upon the passage of this question as certified by the election authority no person may serve as Village President for more than a total of eight (8) years?” (“Petition for Referendum”) in the Village of River Forest, Cook County, Illinois (“Village of River Forest”), are properly complied with, that only public questions be presented to the voters of the Village of River Forest and election authorities which are clear and unambiguous, that elected officials, such as Catherine M. Adduci, who Objector and the voters of the Village of River Forest voted for and elected to the Office of Village President of the Village of River Forest at the April 6, 2021 Consolidated General Election do not have their terms of office cut short, and that only legal and proper public questions by referendum appear on the ballot for the November 5, 2024 Presidential General Election (“Election”).

2. Respondent, Debrorah Borman, has identified herself as the Principal Proponent of, and filed the Petition for, the Referendum. She is also the circulator of some 14 of the 90 petition sheets. Each of the circulators of the Petition for Referendum are also its proponents. Proponents of the Petition for Referendum also include Patricia A. “Patty” Henek, Adduci’s unsuccessful opponent at the April 6, 2021 Consolidated Election (who circulated approximately 10 of the 90 petition sheets) and her husband, John F. Henek, who notarized approximately 71 of the 90 petition sheets contained within the Petition for Referendum.

3. Respondent, the Petition for Referendum, contains the questions sought to be presented to the duly qualified, registered legal voters of the Village of River Forest at the Election.

### **FACTUAL BACKGROUND**

4. The Village of River Forest is an Illinois municipal corporation which has adopted a Municipal Code. The elected official of the Village of River Forest consists of a Village President, Village Clerk and six (6) Trustees.

5. The Municipal Code of the Village of River Forest, Illinois, Title 1 (“Administration”), Chapter 5 (“Village President”) provides:

The president shall be elected every other odd numbered year for a term of four years, and shall serve as president of the board as provided by statute. The date

for inauguration of a newly elected president shall be at the beginning of the regular meeting of the president and board of trustees on the second Monday of May.

(Ord. 3086, 9-27-2004) (“Village of River Forest Ord. 3086, 9-27-2004”)

6. On April 9, 2013, Catherine M. Adducci (“Adduci”), the current Village President of the Village of River Forest, was elected Village President of the Village of River Forest at the April 9, 2013 Consolidated Election. **Exhibit 1, Cook County Clerk’s Office, Suburban Cook County Election Results for the April 09, 2013 Consolidated General Election for Office of Village President of the Village of River Forest**, which is attached and incorporated by reference herein. Adduci’s term as Village President of the Village of River Forest, ran from May 13, 2013 to May 8, 2017. **See Exhibit 2, Official Oath of Office of Adduci dated May 13, 2013**, which is attached and incorporated by reference herein.

7. On April 4, 2017, Adduci was elected Village President of the Village of River Forest at the April 4, 2017 Consolidated Election. **See Exhibit 3, Cook County Clerk’s Office, Suburban Cook County Election Results for the April 04, 2017 Consolidated General Election for Office of Village President of the Village of River Forest**, which is attached and incorporated by reference herein. Pursuant to Village of River Forest Ord. 3086, 9-27-2004, Adduci’s term as Village President of the Village of River Forest, ran from May 8, 2017 to May 10, 2021. **See Exhibit 4, Official Oath of Office of Adduci dated May 8, 2017**, which is attached and incorporated by reference herein.

8. On April 6, 2021, Adducci, was elected Village President of the Village of River Forest at the April 6, 2021 Consolidated Election. **See Exhibit 5, Cook County Clerk’s Office, Suburban Cook County Election Results, Official Certificate of Results, for the April 06, 2021, Consolidated General Election for Office of Village President of the Village of River Forest**, which is attached and incorporated by reference herein. The results for the election of the incumbent village president for the April 6, 2021 Consolidated Election were certified on April 27, 2021 as follows:

Patricia A. “Patty” Henek	1,033	35.17%
Catherine M. Adduci	1,904	64.83%

9. Patricia A. “Patty” Henek is the wife of John F. Henek, who are both registered voters at 731 Bonnie Brae Place, River Forest, IL 60305. John F. Henek is the notary public that appears to have notarized 71 of the 90 petition sheets within the Petition for Referendum. **See Exhibit 6, Petition Sheets Notarized by John F. Henek, which is attached and incorporated by reference.**

10. On May 10, 2021, Adduci took the oath for the office of President of the Village of River Forest. Adduci’s term as Village President of the Village of River Forest, runs from May 10, 2021 to May 12, 2025. Adduci’s 2021-2025 term as Village President of the Village of River Forest ends on May 12, 2025.

## **THE PETITION FOR REFENDUM AND THE ILLINOIS ELECTION CODE**

11. The Petition for Referendum is governed by the Illinois Election Code, 10 ILCS 5/1-1, *et seq.* (“Election Code”). Specifically, Article 28 of the Election Code sets for the requirements for submitting public questions to the voters of the Village of River Forest.

12. On or about July 15, 2024, the Petition for Referendum was filed with the Village Clerk for the Village of River Forest.

13. Pursuant to Section 10 ILCS 5/28-2 of the Election Code, the last day to submit petitions for placement on the ballot for the Election is August 5, 2024.

14. The last day to file an objection to a petition for referendum is August 12, 2024.

15. Objector timely filed the Objector’s Petition to the Petition for Referendum on August 12, 2024.

16. On or about approximately November 26, 2024, the Cook County Clerk, as the election authority for the Village of River Forest, will certify the results of the Election.

17. On November 5, 2024, Adduci will be serving her 2021-2025 term as Village President of the Village of River Forest.

18. From November 5, 2024 until the Cook County Clerk certifies the results of the November 5, 2024 Election, Adduci will be serving her 2021-2025 term as Village President of the Village of River Forest.

19. The circulation period for candidates for the Office of Village President of River Forest seeking election at the April 1, 2025 Consolidated Election begins on August 20, 2024.

20. Effective August 20, 2024, Adduci and her supporters had the right to begin circulating petition for election seeking to place Adduci as a candidate for the Office of Village President of River Forest seeking election at the April 1, 2025 Consolidated Election.

21. The filing period for candidate’s petition for the Office of Village President of the Village of River Forest at the April 1, 2025 Consolidated Election is November 12, 2024 through November 15, 2024, which occurs prior to the Cook County Clerks certification of the results of the November 5, 2024 General Election.

22. The Petition for Referendum is required to comply with the mandatory requirements of Section 16-7 of the Election Code, which provides in relevant part as follows (emphasis added):

Sec. 16-7. **Public Question.** Whenever a public question is to be submitted to be voted upon and has been initiated and certified in accordance with Article 28 of this Code, the election authorities to whom the question is certified shall print the question on the ballot for the proper election, and shall cause it to be submitted in the proper precincts to those electors entitled by reason of their residency to vote on such question. **The substance of such public measure shall be clearly indicated on a separate ballot, and two spaces shall be left upon the right-hand margin thereof, one for the votes favoring the public measure, to be designated by the word, "Yes", and one for the votes opposing the measure, to be designated by the word, "No", as in the form herein given:**

23. The petition sheets contained within the Petition for Referendum states and requests that the "Referendum submitted to the voters of the Village of River Forest for their consideration, by referendum, in the manner provided by law, at the next regular election to be held not less than 92 days at the filing of this petition in said Village." **Petition for Referendum, petition sheets.**

24. The Petition for Referendum consists of 90 petition sheets bearing three (3) separate and distinct petition sheet headings which formats on their face are not the same.

25. The Petition for Referendum contains two (2) petition sheets, including the first petition sheet of the Petition for Referendum, identified in **Exhibit 7, Petition Sheets With the "Yes" Box "√" or "x" Scribbled Over**, which is attached and incorporated by reference herein, which contain the following heading:

Scribbled Over, or presented to the signers for their signature with “Yes” Box “√” or “x” Scribbled Over. Each of the petition sheets identified in **Exhibit 7** are not the same as the petition sheets identified in **Exhibits 8 and 9, below.**

26. The Petition for Referendum contains 32 petition sheets identified in **Exhibit 8 (Petition Sheets With the “Yes” Box Marked with “√” or “x”)**, which is attached and incorporated by reference herein, which contain the following headings:

The Petition Sheets identified in **Exhibit 8** were presented to the signers for their signature with the “Yes” Box “√” or “x” marked, or after the voters signing the “Yes” Box was marked with a “√” or “x”. Each of the petition sheets identified in **Exhibit 8** are not the same as the petition sheets identified in **Exhibits 7 and 9.**

27. The Petition for Referendum contains 56 petition sheets identified in **Exhibit 9 (Petition Sheets Without the Boxes Marked with “√” or “x”)**, which is attached and incorporated by reference herein, which contain the following heading:

Each of the petition sheets identified in **Exhibit 9** are not the same as the petition sheets identified in **Exhibits 7 and 8**.

28. The Petition for Referendum does not set forth a date for an election at which the Referendum would appear on the ballot for the voters of the Village of River Forest and advises the signers that the Referendum would appear at “the next regular election.” See 10 ILCS /28-2(e).

29. The “next regular election” to be held in the Village of River Forest is the Election.

30. Section 28-6 of the Election Code requires that the Petition for Referendum must be “signed by a number of voters equal to at least 8% of the total votes cast for candidates for Governor in the preceding gubernatorial election by registered voters of the municipality...” 10 ILCS 5/28-6.

31. The last gubernatorial election prior to the Election in which the voters of the Village of River Forest votes was the November 8, 2022 Gubernatorial Election.

32. At the November 8, 2022 Gubernatorial Election, the voters of the Village of River Forest, cast 4,941 votes for candidates for the Office of Governor. **See Cook County Clerk, Suburban Cook County Election Results for the November 08, 2022 Gubernatorial General Election, for the Village of River Forest**, a true and accurate copy of said document is attached and incorporated by reference as **Exhibit 10**.

33. Section 28-6(a) of the Election Code requires the Petition for Referendum to be voted upon, for the Election, must comply with the legal requirements set forth in Article 28 of the Election Code and must contain the signatures of not fewer than 396 ( $4,941 \times .08 = 395.28$ ) qualified, registered and legal voters of the Village of River Forest. 10 ILCS 5/28-6(a).

34. The Petition for Referendum, including its content and form must comply with the mandatory requirements set forth in Article 28 of the Election Code. In addition, the signatures within the Petition for Referendum must be gathered and presented in the manner provided for in the Election Code, and otherwise executed in the form provided by law. The Petition for Referendum does not satisfy the legal requirements of Article 28 of the Election Code and contains less than 396 signatures of duly qualified and registered legal voters of the Village of River Forest for the following reasons:

## COUNT I

### Petition for Referendum Violates 10 ILCS 5/16-7

35. Objector reasserts and realleges paragraphs 1 through 34 of Objector’s Petition as paragraph 35 of Count I of Objector’s Petition as though fully set forth herein.

36. The Petition for Referendum fails to comply with Section 16-7 of the Election Code. Section 16-7 of the Election Code provides in relevant part as follows:

**Sec. 16-7. Public Question.** Whenever a public question is to be submitted to be voted upon and has been initiated and certified in accordance with Article 28 of this Code, the election authorities to whom the question is certified shall print **the question** on the ballot for the proper election, and shall cause it to be submitted in the proper precincts to those electors entitled by reason of their residency to vote on such question. **The substance of such public measure shall be clearly indicated on a separate ballot, and two spaces shall be left upon the right-hand margin thereof**, one for the votes favoring the public measure, to be designated by the word, “Yes”, and one for the votes opposing the measure, to be designated by the word, “No”, **as in the form herein given:**

10 ILCS 5/16-7 (emphasis added).

37. The petition sheets are in violation of Section 16-7 of the Election Code and each signature on said petition sheet is invalid and requires that said petition sheets and signatures be removed from the Petition for Referendum because the “yes” and “no” boxes are part of the mandatory format of the referendum, because they are included in between the lines of the Election Code’s statutory format of what constitutes a properly constructed “public question” and ultimately how it will appear on the ballot according to 10 ILCS 5/16-7.

38. The petition sheets are in violation of Section 16-7 of the Election Code as the question appearing in various petition sheets in the Petition for Referendum contains two (2) distinct questions: 1) the question set forth in the petition sheets identified in **Exhibits 7 and 8**; and 2) the question set forth in the petition sheets identified in **Exhibit 9**. The Petition for Referendum when presented to the voters of the Village of River Forest is ambiguous as to the public question that would appear on the ballot and to the election authorities is ambiguous as to the public question that should be certified and printed on the ballot at the Election as two (2) distinct and separate questions are contained on the petition sheets of the Petition for Referendum.

39. The petition sheets are in violation of Section 16-7 of the Election Code and each signature on said petition sheet is invalid and requires that said petition sheets and signatures be removed from the Petition for Referendum because whenever a public question is to be submitted



to voters, the election authorities must print the question on the ballot with two spaces left on the right-hand margin for the voters favoring the public measure, designated by the word “yes,” and for the votes opposing the measure designated by the word “no.” 10 ILCS 5/16-7.

**COUNT II**  
**Petition for Referendum Violates 10 ILCS 5/28-3**

40. Objector reasserts and realleges paragraphs 1 through 34 of Objector’s Petition as paragraph 40 of Count II of Objector’s Petition as though fully set forth herein.

41. The Petition for Referendum fails to comply with Section 28-3 of the Election Code. Section 28-3 of the Election Code provides in relevant part as follows:

Sec. 28-3. Form of petition for public question. Petitions for the submission of public questions shall consist of sheets of uniform size and each sheet shall contain, above the space for signature, an appropriate heading, **giving the information as to the question of public policy to be submitted**, and specifying the state at large or the political subdivision or district or precinct or combination of precincts or other territory in which it is to be submitted and, where by law the public question must be submitted at a particular election, the election at which it is to be submitted. In the case of a petition for the submission of a public question described in subsection (b) of Section 28-6, the heading shall also specify the regular election at which the question is to be submitted and include the precincts included in the territory concerning which the public question is to be submitted, as well as a common description of such territory in plain and nonlegal language, such description to describe the territory by reference to streets, natural or artificial landmarks, addresses or any other method which would enable a voter signing the petition to be informed of the territory concerning which the question is to be submitted. **The heading of each sheet shall be the same.** No signature shall be valid or be counted in considering the validity or sufficiency of such petition unless the requirements of this Section are complied with.

10 ILCS 5/28-3 (emphasis added).

42. The Petition for Referendum contains three (3) separate and distinct petition sheet formats which contain different headings that are not the same in violation of Section 28-3 of the Election Code, and each petition sheet and each signature appearing on said petition sheet invalid requiring that said petitions sheets and signatures be removed from the Petition for Referendum.

43. Each of the petition sheets identified in **Exhibit 7 (Petition Sheets With the “Yes” Box Scribbled Over)** are not the same as the petition sheets in **Exhibits 8 and 9** and are in violation of Section 28-3 of the Election Code and each petition sheet and each signature appearing on said petition sheet invalid requiring that said petitions sheets and signatures be removed from the Petition for Referendum.

44. Each of the petition sheets identified in **Exhibit 8 (Petition Sheets With the “Yes” Box Marked with “√” or “x”)**, are not the same as the petition sheets in **Exhibits 7 and 9** and are in violation of Section 28-3 of the Election Code and each petition sheet and each signature appearing on said petition sheet invalid requiring that said petitions sheets and signatures be removed from the Petition for Referendum.

45. Each of the petition sheets identified in **Exhibit 9 (Petition Sheets Without the Boxes Marked with “√” or “x”)**, are not the same as the petition sheets in **Exhibit 7 and 8** and are in violation of Section 28-3 of the Election Code and each petition sheet and each signature appearing on said petition sheet invalid requiring that said petitions sheets and signatures be removed from the Petition for Referendum.

46. Each of the petition sheets are in violation of Section 28-3 of the Election Code and each petition and each signature appearing on said petition sheet is invalid and requires that said petition sheets and signatures be removed from the Petition for Referendum because the County Clerk cannot, and will be unable to, know on the face of the documents filed in support of the Referendum which of three (3) formats to print on the ballot since there are three (3) separate and distinct variations of the headings which are all different, as identified in **Exhibits 7, 8, and 9**. Such variations create confusion for the County Clerk improperly and illegally inviting him to interpret the intent of the language which must appear on the ballot.

47. The petition sheets are in violation of Section 28-3 of the Election Code and each signature on said petition sheet is invalid and requires that said petition sheets and signatures be removed from the Petition for Referendum because what is presented to voters do not reflect what appears on the ballot.

48. The petition sheets do not sufficiently give information as to the question of public policy, violating Section 28-3 of the Election Code, because the heading is too vague and ambiguous. It legally fails to “use language that does not create doubt”. It cannot ‘stand on its own terms’. It is not ‘self-executing’.

49. The petition sheets do not sufficiently give information as to the question of public policy, violating Section 28-3 of the Election Code, because the heading has to be interpreted and modified in order to be implemented and understood by both the voters and the County Clerk.

50. The petition sheets do not sufficiently give information as to the question of public policy, violating Section 28-3 of the Election Code, because the referendum does not let voters know whether they are voting to shorten the current elected officials’ term, or if the referendum only applies after the current elected officials’ term ends.

51. The petition sheets do not sufficiently give information as to the question of public policy, violating Section 28-3 of the Election Code, because it is unclear whether the phrase “a total of eight (8) years” applies after current Village President’s term is over, allowing that official

to run again, or if the eight (8) years would apply to the current Village President's term, and would thereby cut that current term short as a result.

52. After removal of the petition sheets bearing headings that are not the same as alleged in Count II, the petition sheets notarized by John F. Hennek as alleged in Count III, and the objections set forth in the **Appendix-Recapitulation** as alleged in Count IV, the Petition for Referendum contains less than 396 collected signatures of duly qualified and registered and legal voters of the Village of River Forest signed by such voters in their own proper person with proper addresses, far below the number required under Illinois law.

### **COUNT III** **Violation of the Illinois Notary Public Act**

53. Objector reasserts and realleges paragraphs 1 through 34 and 40 through 52 of Objector's Petition as paragraph 53 of Count III of Objector's Petition as though fully set forth herein.

54. Section 28-3 of the Election Code mandates that each circulator statement of the Petition for Referendum be sworn before an officer authorized to administer oaths in Illinois. Section 28-3 of the Election Code provides in relevant part as follows:

At the bottom of each sheet of such petition shall be added a circulator's statement, signed by a person 18 years of age or older who is a citizen of the United States, stating the street address or rural route number, as the case may be, as well as the county, city, village or town, and state; certifying that the signatures on that sheet of the petition were signed in his or her presence and are genuine, and that to the best of his or her knowledge and belief the persons so signing were at the time of signing the petition registered voters of the political subdivision or district or precinct or combination of precincts in which the question of public policy is to be submitted and that their respective residences are correctly stated therein. **Such statement shall be sworn to before some officer authorized to administer oaths in this State.**

10 ILCS 5/28-3 (emphasis added).

55. The Petition for Referendum contains multiple petition sheets identified in **See Exhibit 6, Petition Sheets Notarized by John F. Henek**, which is attached and incorporated by reference herein, bearing the signature and notary seal of an Illinois Notary Public bearing the name of John F. Henek.

56. The notary public John F. Henek is the husband of Patricia A. "Patty" Henek. Both are registered voters at 731 Bonnie Brae Place, River Forest, IL 60305. Patricia A. "Patty" Henek was an unsuccessful candidate for the Office of Village President of the Village of River Forest at the April 17, 2021 Consolidated Election. Catherine M. Adduci was the successful candidate for the Office of Village President of the Village of River Forest at the April 17, 2021 Consolidated Election. **See Exhibit 5, Cook County Clerk's Office, Suburban Cook County Election**

**Results for the April 06, 2021 Consolidated General Election for Office of Village President of the Village of River Forest, which is attached and incorporated by reference herein.**

57. The approximately 71 separate sheets in the Petition for Referendum bearing the signature and notary seal of an Illinois Notary Public named John F. Henek identified in **Exhibit 6**, were not notarized in accordance with the mandates of the Illinois Notary Public Act, 5 ILCS 312/1-101 *et. seq.* (“Notary Act”), including, but not limited to, Section 3-106 of the Notary Act, and Title 14 Sections 179.900 and 176.910 of the Illinois Administrative Code, making each such petition sheet and all the signatures appearing on each such sheet invalid and requiring that said 71 petitions sheets and signatures thereon be removed from the Petition for Referendum as legally invalid.

58. After removal of the signatures appearing on the petition sheets notarized by John F. Henek as alleged in Count III, removal of the petition sheets bearing headings that are not the same as alleged in Count II, and the objections set forth in the **Appendix-Recapitulation** as alleged in Count IV, the Petition for Referendum contains less than 396 collected signatures of duly qualified and registered and legal voters of the Village of River Forest signed by such voters in their own proper person with proper addresses, far below the number required under Illinois law.

**COUNT IV**  
**Petition for Referendum Contains Less Than The Statutorily**  
**Required Number of Signatures**

59. Objector reasserts and realleges paragraphs 1 through 34, 40 through 52, and 53 through 58 of Objector’s Petition as paragraph 59 of Count IV of Objector’s Petition as though fully set forth herein.

60. Objector attaches and incorporates by reference the **Appendix-Recapitulation** setting forth the objections made therein as part of this Objector’s Petition.

61. The Petition for Referendum contains petition sheets with the names of persons who are not registered voters at the addresses shown opposite their respective names, as it set forth specifically in the Appendix-Recapitulation, under the heading, Column a, “Signer not registered at address shown”, in violation of the Election Code.

62. The Petition for Referendum contains the names of persons who did not sign said papers in their own proper persons, and said signatures are not genuine and are forgeries, as is set forth specifically in the Appendix-Recapitulation, under the heading, Column b, “Signer’s signature not genuine”, in violation of the Election Code.

63. The Petition for Referendum contains petition sheets with the names of persons for whom addresses are stated which are not in the Village of River Forest, Cook County, State of Illinois, and such signatures are not valid, as set forth specifically in the Appendix-Recapitulation, under the heading Column c, “Signer resides outside district”, in violation of the Election Code.

64. The Petition for Referendum contains the names of persons for whom the signer's address is missing or incomplete as is set forth specifically in the Appendix-Recapitulation, under the heading Column d, "Signer's address missing or incomplete", in violation of the Election Code.

65. The Petition for Referendum contains the names of persons who have signed the Petition for Referendum more than one time as is set forth specifically in the Appendix-Recapitulation, under the heading Column e, "Signer signed Petition more than once at Sheet/Line indicated", in violation of the Election Code.

66. After removal of the signatures for the objections set forth in the **Appendix-Recapitulation** as alleged in Count IV, appearing on the petition sheets notarized by John F. Henek as alleged in Count III, and removal of the petition sheets bearing headings that are not the same as alleged in Count II, the Petition for Referendum contains less than 396 collected signatures of duly qualified and registered and legal voters of the Village of River Forest signed by such voters in their own proper person with proper addresses, far below the number required under Illinois law.

67. The Petition for Referendum contains less than 396 collected signatures of duly qualified and registered and legal voters of the Village of River Forest signed by such voters in their own proper person with proper addresses, and otherwise in conformity with the mandatory requirements of the Election Code, far below the number required under Illinois law, as set forth by the objections recorded in the Appendix-Recapitulation.

**WHEREFORE**, your Objector prays that the Petition for Referendum which seeks the a placement of the question “Shall the terms of office of the Village President of the Village of River Forest, Cook County, Illinois be limited so that, effective upon the passage of this question as certified by the election authority no person may serve as Village President for more than a total of eight (8) years?” in the Village of River Forest, Cook County, Illinois, of the Village of River Forest, Cook County, State of Illinois, be declared to be insufficient and not in compliance with the laws of the State of Illinois, and that this Petition for Referendum proposing a Public Question be not printed upon the official ballot for the November 5, 2024 General Election for submission to the voters of the Village River Forest.
